On the 11th day of November 1942, the 345 Bombardment Group was formed in Columbia, S.C. The month of November brought back




many memories to most of us. Some finished our schooling at the North American Aviation Co. school at Englewood, CA, studying the B-25 bomber.








Surrender Escort Plane Dedicated

The Kalamazoo Aviation History Musuem says its restored R-25 J Mitchell is among the best looking in any museum where. It's also the plane that intercepted the Japanese rrender Envoys and escorted them on their mission. The ne, now on display at the Kalamazoo, MI museum, sports alcon nose and Apache tail, .50 cal. side packs, top turret and the individual exhaust stacks of the J model. This particular plane had been modified for commercial work and was essentially a cargo carrier. It had originally been an H model and served with the 498th from July to September 1944. Over 10,000 man-hours were put into the restoration by volunteers and the museum says detail of the work is far beyond what the typical museum visitor would notice. The grand unveiling of the plane included attendance by four of the surrender flight crew members of the #115 Betty Bomber. Herb Garland (he missed a 345th B.G. reunion for the first time in Vegas), John Polansky (radio/gunner), Bob Cornwell (copilot) and Merl Wooden (crew chief). "It was great seeing all of the young people interested in the flight, the B-25 and in our war memories," Wooden said. The dedication was held on Veterans Day, with the unveiling activities spanning November 9-11, 1990.

During our tour of the tropics many of the ground personnel were given 10 day leaves to Mackay, a "I town south of Townsville. The Red Cross had a een with real milk and ice cream. A chicken or k dinner in a restaurant cost two shillings, about cents American.



The hotel in the picture was just across the river from the town, about a quarter of a mile and our transportation was by rented bikes. It cost almost a pound note, \$3.40 American, to stay for a week. It was painted pink with white trim and every room had French doors on the balcony side. The hotel pub was open for two short periods every day and served warm beer from a large copper pitcher. My roommate was one of our parachute riggers, George Stacy, a schoolteacher from the South. I would sure like to hear from him or about him.

On our return to the islands we ran into a huge cal storm. The pilot said we did not have enough o go back and couldn't fly around the storm. We told to fasten seat belts, put on Mae Wests and aluables inside our shirts. We climbed to 10,000 feet and headed into the black sky. We pitched and bounced something fierce; came out skimming the whitecaps. C-47s do fly by flapping their wings.


